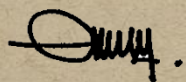

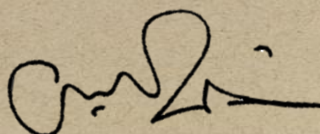

CODE OF ETHIC (Article 19, MFA Constitution)

- (1) Article 3 (3) of the MFA Constitution with regard to ethical practice of professional business conduct among the members necessarily mean that members of the Association shall be subject to the code of ethics as follows :-
- i. Members are not allowed to sell, offer to sell, distribute any proceeds or products, or provide services, or getting involved in sales promotion or distribution under any terms or representations that tends to cause confusion or deception to purchasers or into believing that the offer is a franchise.
 - ii. Members are not allowed to infringe the trade mark, trade name, corporate identity, slogan or any sign or other identification belonging to other franchisor in any way or style that tends to mislead or deceive purchasers and potential purchasers.
 - iii. Every franchisor has overall responsibility to provide a complete proven business format and proven to be a viable business if the franchisee complies with the guidelines in the format of the said business.
 - iv. Each franchisee is responsibility to protect all business formats and its content of any trade secrets owned by the franchisor.
 - v. All information essential to the franchise relationship must be presented accurately and fully in writing to prospective franchisees before any documents can be binding on both parties.
 - vi. Each franchise agreement must state with clarity the responsibilities and obligations of the parties involved and all the other terms stated therein shall be free from doubt or confusion.
 - vii. Each franchise agreement and all important matters to the arrangement and relationships established must be made in writing and copies thereof shall be given to the franchisee after being executed.
 - viii. Every franchisor must select and appoint only franchisees with suitable background, which has the basic skills, education, and personal qualities with sufficient capital to succeed. Any discrimination based on race, color, religion, nationality or sex are prohibited.
 - ix. Every franchisor shall be responsible to supervise the franchisee's business to ensure that the obligations of the contract between both parties are complied with and the public interest is protected.
 - x. Fair and just shall be the utmost nature in all dealings between the Franchisors and Franchisee and in the occasion of any breach of agreement a reasonable time shall be given for the party to remedy the breach.
 - xi. Every franchisor shall strive to resolve any complaint, dissatisfaction, objection and misunderstanding with its franchisee in good faith through communication and negotiation in a fair and reasonable manner.
 - xii. Each franchisee is responsible to pay certain fees or royalties, or fulfill certain purchases from the franchisor as set forth in the franchise agreement and the Franchisor is to assume responsibility to provide management support to the Franchisee.
 - xiii. Each member is responsible to protect the interest of the consumers and the National interest and jointly responsible to maintain the good image of Franchise Industry.
 - xiv. Support Institution has overall responsibility to provide effective facilitation of business practices of franchisors and franchisees, assumes responsibility of providing advice and complete referral, to provide a fair guidance, friendly and honest, uphold responsibility to help franchisors and franchisees as a whole so that all the franchise "Family" will be more viable, independent, competitive and resilient, and assumes responsibility as "friends in business" having mutual understanding and adopt the concept of win-win situation.
 - xv. Each member must be responsible of helping each other and shall not compete in the negative way.
 - xvi. Each member must comply with all applicable laws and regulations of the country.
- (2) Rules relating to any action on appeal for dissatisfaction by any members or parties interested with the ideals of the Association, hereinafter known as the Rules of the Sub-Committee on Membership and Ethics, attached herewith as Appendix.

SYARAT KELULUSAN SIJIL AKUAN PENDAFTARAN SYARIKAT BUMIPUTERA

1. SYARAT AM

- 1.1 Pihak syarikat hendaklah sentiasa berusaha untuk mengekal dan mempertingkatkan kedudukan supaya:
 - 1.1.1 Kedudukan majoriti Bumiputera hendaklah sentiasa melebihi 51% di dalam pemilikan ekuiti, keahlian Lembaga Pengarah, jawatan Ketua Eksekutif, Pengarah Urusan atau Pengurus Besar, jawatan-jawatan penting lain (Key post), Kakitangan syarikat di peringkat pengurusan dan juga pekerja.
 - 1.1.2 Bagi bidang percetakan, kedudukan 100% Bumiputera hendaklah sentiasa dikekalkan dari segi ekuiti, Lembaga Pengarah/ Pengarah, Pengurusan dan Pengurusan Kewangan. Bagi pekerja hendaklah tidak kurang 80% Bumiputera dan tiada penglibatan bukan warganegara.
 - 1.1.3 Bagi bidang agen pengembaraan, kedudukan 100% Bumiputera hendaklah sentiasa dikekalkan dari segi ekuiti, Lembaga Pengarah/ Pengarah, Pengurusan, Pengurusan Kewangan dan pekerja.
 - 1.1.4 Secara majoriti Bumiputera memainkan peranan penting di dalam urus niaga syarikat, pengawasan perjalanan syarikat, pengurusan kewangan syarikat, membuat keputusan-keputusan penting dan mewakili syarikat di dalam mesyuarat-mesyuarat dan lain-lain urusan rasmi seumpamanya.
- 1.2 Jika berlaku sebarang perubahan di dalam syarat-syarat yang dinyatakan di atas, maka pihak Kementerian Kewangan hendaklah diberitahu dengan segera supaya pindaan dapat dibuat di dalam Rekod Pendaftaran. Setiap perubahan ke atas maklumat tersebut hendaklah dikemaskinikan secara *online* di Modul Kemaskini Profil di alamat www.eperolehan.gov.my dalam tempoh masa dua puluh satu (21) hari dari tarikh perubahan tersebut berlaku. Kegagalan syarikat di dalam memberikan maklumat tersebut boleh menimbulkan keraguan pihak Kementerian Kewangan Malaysia terhadap ketulenan taraf Bumiputera syarikat.
- 1.3 Sekiranya Kementerian Kewangan Malaysia mendapati syarikat telah melanggar syarat-syarat yang ditentukan di atas, ataupun telah menyerahkan pengurusan syarikat dan kontrak yang diperolehi kepada pihak-pihak lain, maka pengiktirafan sebagai syarikat Bumiputera akan ditarik balik dan status dibatalkan dalam sistem ePerolehan.

2. TERMA DAN SYARAT TAMBAHAN

- 2.1 Aku janji syarikat berhubung dokumen sokongan/surat/gambar dan sebagainya yang dikemukakan adalah sahih dan betul.
- 2.2 Hak Kerajaan untuk menjalankan siasatan dan lawatan fizikal selepas kelulusan bersyarat Sijil Taraf Bumiputera (STB) dikeluarkan.
- 2.3 Hak Kerajaan untuk mengenakan tindakan ke atas syarikat sekiranya didapati terdapat pelanggaran terma dan syarat pematuan termasuk penipuan/pemalsuan maklumat setelah siasatan dan lawatan oleh BPKU disempurnakan. Antara tindakan yang boleh diambil oleh Kerajaan adalah:
 - 2.3.1 Penarikan semula atau pembatalan STB yang telah diluluskan secara serta merta;
 - 2.3.2 Kerajaan berhak untuk menamatkan kontrak semasa yang sedang berkuatkuasa hasil daripada pemilikan STB tersebut dan Kerajaan tidak bertanggungjawab untuk menanggung apa-apa kos dan kerugian yang ditanggung syarikat akibat penamatan kontrak berkenaan menurut terma dan syarat perjanjian yang telah ditandatangani oleh Kerajaan dengan syarikat;
 - 2.3.3 Syarikat dan pemilik serta Ahli Lembaga Pengarah syarikat akan disenaraihitam daripada menyertai sebarang perolehan/projek Kerajaan selama tiga (3) hingga lima (5) tahun, tertakluk kepada keputusan Jawatankuasa Tindakan Tatatertib, Kementerian Kewangan; dan
 - 2.3.4 Peruntukan kehendak pematuan terhadap undang-undang yang berkuat kuasa termasuk Akta Kontrak 1950 [Akta 136], Kanun Keseksan dan sebagainya yang mana berkaitan.

3. PENGGANTUNGAN/PEMBATALAN PENDAFTARAN

- 3.1 Kementerian Kewangan berhak mengenakan tindakan tatatertib ke atas syarikat dan membatalkan maklumat berkaitan pendaftaran syarikat sekiranya:
 - 3.1.1 Taraf Bumiputera syarikat dilucutkan atau ditarik balik dan dibatalkan dalam Sistem ePerolehan.
 - 3.1.2 Pendaftaran syarikat digantung atau dibatalkan dalam Sistem ePerolehan.
 - 3.1.3 Lain-lain pelanggaran syarat yang membolehkan Kementerian Kewangan Malaysia memutuskan taraf Bumiputera ditarik balik dan dibatalkan dalam Sistem ePerolehan.

4. HAK KERAJAAN

- 4.1 Sijil Akuan Pendaftaran Syarikat Bumiputera yang dikeluarkan secara manual atau *Virtual* adalah HAK KERAJAAN dan semua maklumat dalam Sistem ePerolehan adalah muktamad.

5. PENYERTAAN PEROLEHAN KERAJAAN

- 5.1 Sijil Akuan Pendaftaran Syarikat Bumiputera tidak perlu ditunjukkan semasa mengambil dokumen perolehan Kerajaan (pembelian terus, tender/sebut harga dan lain-lain kaedah perolehan) kecuali bagi Agensi Kerajaan yang tiada capaian internet.
- 5.2 Syarikat hendaklah memastikan pendaftaran dengan Kementerian Kewangan Malaysia masih sah laku sepanjang tempoh kontrak berkuat kuasa.

6. PERINGATAN MENGENAI KESALAHAN RASUAH

- 6.1 Sebarang perbuatan atau percubaan rasuah untuk menawar atau memberi, meminta atau menerima apa-apa suapan secara rasuah kepada dan daripada mana-mana orang berkaitan perolehan Kerajaan merupakan suatu kesalahan jenayah di bawah Akta Suruhanjaya Pencegahan Rasuah Malaysia 2009 [*Akta 694*].
